

#### **Review petition**

- According to Constitution, any judgement given by Supreme Court in normal course is final and binding.
- Constitution under Article 137 gives Supreme Court power to review its judgments or orders.
- Review petition must be filed within **30 days** of judgment given.
- Review petitions are heard through "circulation" by judges in chambers.
  - It can be done except in cases of **death penalty**.
- They are **not** heard in **open court**.
- Lawyers makes their case through written submissions and not oral arguments.
- The judges who passed original verdict can also hear review petition.
- According to **Civil Procedure Code** (CrPC) and Supreme Court Rules any aggrieved person can seek a review.

#### Grounds for review

- Court can review its rulings to correct a **patent error** but **not** minor mistakes.
- In 2013, the Supreme Court laid down 3 grounds for seeking a review-
  - Discovery of new and important matter or evidence which was not previously in knowledge of petitioner or could not be produced by him.
  - Mistake or error can be noticed on the face of the record.
  - Or any other **sufficient reason** that is **analogous** to other two grounds.
- In Union of India v. Sandur Manganese & Iron Ores Ltd case court laid down nine principles on when a review is allowed.

#### Kakori Train robbery

- Train robbery at Kakori was **HRA** (Hindustan Republican Association)'s **first major** action on **9 August 1925**.
- Attack was done on Number 8 Down Train running between Shahjahanpur and Lucknow.



- It carried treasury bags to be deposited in British treasury in Lucknow.
- Revolutionaries' objective to rob was to fund HRA and garner public attention for their work.
- Rajendranath Lahiri, a member of HRA inside train pulled chain to stop train.
- 10 revolutionaries like **Ram Prasad Bismil** and **Ashfaqullah Khan** looted treasury bags (containing approx Rs 4,600) and escaped to Lucknow.
- British authorities arrested **Bismil** in October, **Ashfaqullah** after a year.
- Only major leader of HRA who evaded arrest was Chandrashekhar Azad.
- 4 revolutionaries hanged in **December 1927** were-Rajendranath Lahiri, Ashfaqullah Khan, Ram Prasad Bismil, Thakur Roshan Singh.

#### Sachindra Nath Sanyal

- He founded **Hindustan Republican Association** (HRA) in October 1924 after **non-cooperation movement** ended.
- He was author of HRA manifesto- The Revolutionary that was distributed in major cities of North India.
- He founded a branch of **Anushilan Samiti** in **Patna** in 1913.
- He was a mentor for revolutionaries like Chandrasekhar Azad, Jatindra Nath Das and Bhagat Singh.
- He was involved in plans of **Ghadar Conspiracy** and went underground after it was exposed in **February** 1915.
- He was also jailed by British for his involvement in Kakori Conspiracy.
- He died in Gorakhpur Jail due to tuberculosis on 7th February 1942.

#### Delhi Conspiracy Trial 1912

- He along with **Rashbehari Bose** attacked **Viceroy Hardinge** and injured him when he was entering new capital of **Delhi**.
- He was sentenced to life in **Cellular Jail** in the Andaman and Nicobar Islands for involvement in **Delhi** conspiracy. Later, he was released.
- He wrote book titled Bandi Jeevan- A Life of Captivity, 1922 during imprisonment.

#### Indian Bureau of Mines (IBM)

- It was established in 1948 under Ministry of Mines.
- It is a multi-disciplinary government organisation under Department of Mines.

- It promotes conservation by scrutiny, geological studies and approval of mining plans and schemes.
- It promotes scientific development of mineral resources.
- It protects **environment** in mines other than coal, petroleum & natural gas, atomic minerals and minor minerals.
- It prepares minerals maps to National Mineral Inventory of minerals resources.
- It provides technical consultancy services and data to mineral industry.
- It is headed by Controller General.
- It has six technical divisions with its head-quarters at Nagpur.
- It has Modern Mineral Processing Laboratory and Pilot Plant.
- It performs regulatory functions by enforcing-
  - Mineral Conservation and Development Rules, 1988.
  - Mines and Minerals (Development and Regulation) Act, 1957.
  - Mineral Concession Rules, 1960.
  - Environmental (Protection) Act, 1986 and other such rules.
- It imparts training to technical and nontechnical officials of IBM and persons from mineral industry.

#### Lavani

- Lavani is combination of song and dance performed by Maharashtra and Konkan or Coastal Region.
- Word 'Lavani' is derived from the word Lavanya, which means 'beauty'.
- It was originated to morally boost war troops during 18th and 19th century.
- It reached its popularity during **Peshwa Dynasty**.
- It is generally performed by Dhangars or shepherds of Sholapur district, Maharashtra.
- The dance form contains tales of birth of **Biruba**, deity of Dhangars.
- It is categorized in 2 parts- Nirguni Lavani and Shringari Lavani.
  - Nirguni Lavani deals with philosophy.
  - Shringari Lavani deals with sensuality.
- **Themes** childbirth, love and separation of a husband and wife, endeavors of soldiers and social life such as politics, religion, romance, etc.
- Performance in front of a large audience is called Padhachi Lavani.
- Performance for small selected audience is called Baithakichi Lavani.
- At end of Lavani replica of the Manmathas mount is burnt.
- Male performers are called Nats or Kinnars.

#### Performance of Lavani

- It is performed by **women** who dance on beats of a **Dholak**.
- Other instruments are **cymbal** (Manjeera), **Tuntuni** (a string instrument), **Daf** (similar to a tambourine) and **harmonium**.
- Tempo of music and dance is fast.

#### **Costumes of Lavani**



- Performers wears ankle bells called Ghungroo.
- Saree worn by performers is longer and is called a nauvari wrapped around in a kashta drape.
- Performers tie their hair back in bun called a juda or ambada.
- Performers wears heavy jewelry- necklace, earrings, a nose ring called **nath**, and bangles.
- They wear **kamarpatta** belt at **waist**.
- Performers applies large red bindi on forehead.
